LODGING AT THE INTERCONTINENTAL HOTEL

Information regarding lodging complies with FINRA Cash / Non-Cash Compensation Rules as follows:

- Subject to availability, pre-event / post-event extensions are available at your own expense at a Davis room-block rate of \$379 / night + taxes
